Skin Cancer Awareness

- Doctors did fake cancer surgeries in Illinois & Wisconsin
- They told patients, “you’re all set” when their cancer was not treated
- Co-conspirators sabotaged the whistleblower’s care of patients.
- At least two former patients died
- Culprits still practicing medicine

Mental Health Awareness

- Hospitals and oversight used gaslighting to discredit a healthcare whistleblower
- A hospital falsified “evidence” to blame a whistleblower for medical malfeasance
- Falsified “evidence” is hidden from the public, healthcare workers, & civil courts
- The Martha Mitchell Effect: officials call concern for crime a paranoid delusion

Congress gave hospitals & oversight all power: they can prevent evidence discovery.

• CUSTODIAL DUTY FAILURES

WI Judge Thomas H. Ryan & prosecutor Joost Kap deleted Rx ID theft evidence.
